**Subject:** Proposed modification to the National Station Access Conditions 2014

Dear Gerry

ORR has sought views on a proposed Modification to the National Stations Access Conditions 2013 (England and Wales). This is a formal Conditions Change Proposal consultation in accordance with Condition B6 of the NSACs on a proposal to change those Access Conditions.

- Arriva Trains Wales/Trenau Arriva Cymru Limited agrees to the Modified Condition 11.2.1 to Part F of the National Station Access Conditions (England & Wales).
- Arriva Trains Wales/Trenau Arriva Cymru Limited agrees to the formal Conditions Change Proposal consultation in accordance with Condition B6 of the NSACs on a proposal to changes to those Access Conditions.
- Arriva Trains Wales/Trenau Arriva Cymru Limited agrees to a number of changes to be made to the Station Access Conditions, including changes to the NSACs. In particular, Appendix A to Annex 4 has directed change to Part F of the NSACs to amend the indexation provisions.
- Arriva Trains Wales/Trenau Arriva Cymru Limited agrees that the error in Appendix A to Annex 4, Condition F11.2.1 (ii) should be altered to change paragraph 42.4.1.2 to Condition F11.4.1.2.
- Arriva Trains Wales/Trenau Arriva Cymru Limited agrees that Condition F11.2.1 of the NSACs and imported into the NSACs from 1 April should read Condition F11.4.1.2.
- Arriva Trains Wales/Trenau Arriva Cymru Limited agrees with the view that it is necessary to modify Condition F11.2.1 of the NSACs to rectify the error contained in the PR13 stations review notice and subsequently imported into the NSACs with effect from 1 April 2014.
- Arriva Trains Wales/Trenau Arriva Cymru Limited notes that the letter begins the consultation under Condition B6.3.1 of the NSACs and its modification to F11.2.1 of the NSACs.
- Arriva Trains Wales/Trenau Arriva Cymru Limited notes that any modifications made to the NSACs will not become effective until a period of 180 days from the date that ORR will issue a notice to approve the modifications.
- Modified Condition 11.2.1 to Annex B of the National Station Access Conditions (England & Wales).
- Annex C includes an item which has been struck off and a Condition F11.4.1.2 included.
