Network licence condition 7 (land disposal): Burrows Yard, Swansea

Decision

- 1. On 9 October 2014, Network Rail gave notice of its intention to dispose of land at Burrows Yard, Swansea (the land) in accordance with paragraph 7.2 of condition 7 of its network licence. The land is described in more detail in the notice (copy attached).
- 2. We have considered the information supplied by Network Rail including the responses received from third parties you have consulted. Further to the notice, Network Rail clarified that the two hatched blue areas shown on plan 63336 relate to a sub-lease between DB Schenker Rail (UK) Limited (DBS) and Gower Chemicals. Network Rail has confirmed that it cannot dispose of that land until either the lease expires in 2026 or the other parties to the lease seek termination.
- 3. For the purposes of condition 7 of Network Rail's network licence, ORR has carefully considered the notice and further information. While we are content to consent to the disposal of the land outlined in red on plan 63336 in accordance with the particulars set out in the notice, we do not consent to any disposal (or future disposal), at this stage, of the other land comprising the two hatched blue areas. We consider that we do not have the necessary information to proceed with their consideration.

Reasons for decision

- 4. We are satisfied that Network Rail has consulted all relevant stakeholders on the notice. No alternative reasonably foreseeable railway use for the land was identified. We note:
- that proposed disposal will not adversely affect current or future railway operations;
 Network Rail has stated that it will retain the ability to provide an access route to the freight site through the land proposed for development; and
- the site is remote from any passenger line.
- 5. Network Rail also stated the proposed disposal would include arrangements to install new railway boundary fencing, either by Network Rail, DBS or the purchaser. This will need to be reflected through appropriate provisions in the sale documentation. However, under health and safety legislation Network Rail retains ultimate responsibility for preventing unauthorised access to its infrastructure.



- 6. Based on all the evidence we have received and taking into account all the material facts and views relevant to our consideration under condition 7, we are satisfied that there are no specific issues for us to address in respect of the proposal to dispose of the land outlined in red on plan 63336. However, in respect of the other land comprising the two hatched blue areas, our consent does not extend to it as we cannot consider it as part of the application. The reason for this is because a disposal is not currently possible and we cannot ascertain at this stage all the circumstances and potentially relevant issues surrounding any future opportunity to dispose of that land. We will consider any proposals for those areas once they are fully formed.
- 7. We have had regard to our decision criteria in *Land disposal by Network Rail: the regulatory arrangements, December 2013*, ¹ and balanced our section 4 duties given to us under the Railways Act 1993. In doing so we have given particular weight to our duty to exercise our functions in a manner which we consider best calculated to "protect the interests of users of railway services".
- 8. On that basis, we have therefore concluded that the proposed disposal of the land outlined in red on plan 63336 is not against the interests of users of railway services and that our consent should be granted.





This report is provided as a supplement to our forms for the proposed disposal of land at

Site location and description: Swansea Fabian Way – Part of the premises leased to DBS and known as Burrows Yard.

We have consulted in relation to this evaluation, and summarise the results of this as follows:

Summary of position regarding responses: 33 stakeholders were consulted, initially on 26th September 2013. All the Consultees save RCL Roadways and British Transport Police responded. Freightliner objected on the basis that it wished to investigate the potential for a road to rail freight transfer facility on the site. The other consultees did not wish to object or had no comments or supported the disposal. Welsh Government added that its Property Section should be kept informed and Swansea Council that it may wish to route a cycleway through the disposal area.

Because there was a delay of more than six months since the original consultation, it was necessary to reconsult on 2nd May 2014.

28 consultees (including BTP) responded to the 2014 consultation; all confirmed either "no comment" or "no objection" or "no change of views".

Grand Central Railway Co., West Coast Railway Co., Hutchinson Ports and South West Wales Integrated Transport Consortium (SWWITCH) did not respond to the 2014 consultation, although we sent 3 reminders by email, but as they had all responded and raised no objection in the earlier consultation we have assumed their views have not changed.

RCL Roadways did not respond to either consultation, although it was sent a total of 4 reminders. RCL is not considered to be a key stakeholder in this case.

Network Rail gave Freightliner until 4th August 2014 to provide evidence of a clear, feasible and funded plan to use the site for a rail freight operation. That date passed and the evidence was not provided.

On 8th September 2014 Freightliner withdrew its objection to the disposal.
