## Extension to deadline in Review Initiation Notice pursuant to Schedule 4A of the Railways Act 1993

In light of current circumstances, we recognise that the Scottish Ministers will require more time to provide their High-Level Output Specification (HLOS) and their Statement of Funds Available (SoFA). We have therefore extended the date for submission of the Scottish Ministers' HLOS and SoFA for Control Period 7 (CP7) to 27 January 2023.

This represents the second extension to the Scottish Ministers' HLOS and SoFA deadline. We issued the first Review Initiation Notices on 9 June 2022, which requested Scottish Ministers' HLOS and SoFA by 30 November. On 27 October 2022, we extended this deadline to 9 January 2023.

Funders' HLOS and SoFA are a statutory component of the periodic review and are one part of a larger and legally timebound process which runs up to the start of CP7 on 1 April 2024. This is designed to ensure all stakeholders have the opportunity to play their part in the process. Meeting this new deadline is critical to the success of completing our periodic review by the statutory deadlines, including to ensure appropriate funding is in place for Network Rail for CP7.

In the unlikely event that we do not receive the HLOS and SoFA by 27 January, we would need to make preparations to use alternative arrangements via amendments to track access contracts. Any alternative arrangements would apply to Network Rail and train operators at a GB-level. We recognise that instigating alternative arrangements would be disruptive and we are working closely with Transport Scotland and Network Rail to ensure we continue with the periodic review as planned.
