Publication of draft determination for PR23

Today we published our draft determination for the 2023 periodic review (PR23). We are consulting with stakeholders on our assessment of Network Rail's plans with respect to its operation, support, maintenance and renewal (OSMR) of the national rail network for the five-year period from 1 April 2024, known as control period 7 (CP7).

ORR's periodic review is one of the principal mechanisms by which we hold Network Rail to account and secure value for money for users and funders of the railway. Our focus, during PR23 has remained on the four objectives we outlined in our launch letter in June 2021: safety, performance, asset sustainability and efficiency.

Network Rail's plans for CP7 involve expenditure of £44.8 billion for the railway infrastructure in Great Britain (£40 billion for England & Wales and £4.8 billion for Scotland). Our assessment identifies that while Network Rail's plans largely deliver against government priorities, a greater focus is needed on train performance and renewing core assets. Better train performance will benefit passengers and freight customers, while core assets like track, structures and earthworks need to be resilient - especially with the challenges presented by climate change.

Our assessment of the above along with our draft decisions on all areas of the periodic review are set out in a suite of documents as follows:

- Executive summaries of our determinations for England & Wales and for Scotland.
- Overviews of our draft decisions for England & Wales and for Scotland.
- A consolidated table of decisions for England & Wales and Scotland.
- An introduction document which provides an overview of the PR23 process, our approach to assessing Network Rail's plans and next steps.
- Settlement documents for each of the England & Wales regions, Scotland and the System Operator detailing our expectations about the funding that will be allocated to each region and the System Operator and the outputs that will be delivered by them.
- Supporting documents which set out our technical assessments in the areas
 of health and safety, outcomes, sustainable and efficient costs, National
 Functions and other income.

 Policy positions covering access charges, the performance and possessions incentive regimes (including supporting impact assessments), our intended approach for the financial framework and for Managing Change during CP7.

We welcome responses to our draft determination by 31 August 2023, using the consultation response proforma.

Stakeholder events

We also invite stakeholders to hear more about our draft decisions and discuss them with us during events planned for July. We will send an invitation with instructions on how to book shortly.

Next steps

We will also be issuing a consultation in July on drafting changes to access contracts and an update on open access airport services. Network Rail will also publish its CP7 draft price list in July.

We will consider responses to our draft determination ahead of our final determination which is due by the end of October 2023. This will set out our decisions on what Network Rail needs to deliver for CP7.

Following publication of our final determination, we will move to implementing PR23. This will involve issuing Review Notices in December 2023 and subsequently Notices of Agreement and Review Implementation Notices which will give effect to the decisions made in time for CP7 to commence from 1 April 2024.

Next year, Network Rail will issue a Delivery Plan for CP7 that is consistent with our final determination. The Secretary of State signs off the final version of the Delivery Plan, having considered the views of Scottish Ministers.
