# THIS FIFTY-SECOND SUPPLEMENTAL AGREEMENT is dated made

#### **BETWEEN:**

- (1) **NETWORK RAIL INFRASTRUCTURE LIMITED**, a company registered in England under number 2904587 having its registered office at Network Rail, Kings Place, 90 York Way, London N1 9AG ("Network Rail"); and
- (2) **LONDON & BIRMINGHAM RAILWAY LIMITED**, a company registered in England under number 05814584 having its registered office at 41-51 Grey Street, Newcastle upon Tyne, NE1 6EE (the "Train Operator").

#### WHEREAS:

- (A) The parties entered into a Track Access Contract (Passenger Services) dated 11 November 2007 in a form approved by the Office of Rail Regulation pursuant to section 18(7) of the Act, as amended by various supplemental agreements each in a form approved by ORR pursuant to section 22 of the Act (the "Contract").
- (B) The parties now propose to enter into this Supplemental Agreement in order to amend the Contract as described herein.

#### IT IS HEREBY AGREED as follows:

#### 1. **INTERPRETATION**

In this Supplemental Agreement, unless the context otherwise requires:

- (A) words and phrases defined in, and rules of interpretation set out in, the Contract shall have the same meaning and effect when used in this Supplemental Agreement; and
- (B) "Effective Date" means whichever is the later of 0200 on 14th December 2014 and the date upon which the ORR issues its approval, pursuant to the Section 22 of the Act, of the terms of this Supplemental Agreement

#### 2. EFFECTIVE DATE AND TERM

The amendments to the Contract as set out in this Supplemental Agreement shall have effect from the Effective Date and shall cease to have effect on the Expiry Date or earlier termination of the Contract.

#### 3. AMENDMENTS TO SCHEDULE 5 OF THE CONTRACT

- 3.1: Table 2.1 (Passenger Train Slots) for Service Group EJ02 (Trent Valley) shall be deleted and replaced with the new version set out as Appendix 1 to this Supplemental Agreement
- 3.2: Table 2.1 (Passenger Train Slots) for Service Group EJ03 (West Midlands New St Locals) shall be deleted and replaced with the new version set out as Appendix 2 to this Supplemental Agreement
- 3.3: Table 2.1 (Passenger Train Slots) for Service Group EJ04 (West Midlands Inter-Urban) shall be deleted and replaced with the new version set out as Appendix 3 to this Supplemental Agreement
- 3.4: Table 2.1 (Passenger Train Slots) for Service Group EJ05 (WCML: London Northampton) shall be deleted and replaced with the new version set out as Appendix 4 to this Supplemental Agreement
- 3.5: Table 4.1 (Regular Calling Patterns) for Service Group EJ04 (West Midlands Inter-Urban) shall be deleted and replaced with the new version set out as Appendix 5 to this Supplemental Agreement

#### 4. **GENERAL**

The parties agree that the Contract, as amended by this Supplemental Agreement, shall remain in full force and effect in accordance with its terms, and during the period in which the amendments made by this Supplemental Agreement are to have effect, all references in the Contract to "the contract" or, as the case may be, the "Agreement", "herein", "hereof", "hereunder" and other similar expressions shall, unless the context requires otherwise, be read and construed as a reference to the Contract as amended by this Supplemental Agreement.

#### 5. THIRD PARTY RIGHTS

No person who is not a party to this Supplemental Agreement shall have any right under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of this Supplemental Agreement.

#### 6. **LAW**

This Supplemental Agreement shall be governed by, construed and given effect to in all respects in accordance with English Law.

#### 7. COUNTERPARTS

This Supplemental Agreement may be executed in two counterparts which, taken together, shall constitute one and the same document. Either party may enter into this Supplemental Agreement by signing either of such counterparts.
