it applies to update various details for Service Groups 4068, 6050, 6070, 4075 and 6103 in the rights table in Schedule 5 to match those required for the December 2016 timetable;

changes to firm "one hour window" rights include:

31 additional rights - many are major re-timings of existing flows,

26 rights surrendered,

27 amended,

12 transferred, some subject to minor changes;

a "hub" at Didcot, with traffic concentrated onto single trains with feeder services, has increased network capacity;

a stable train plan is "beneficial to improving performance".

Transport Focus also notes that the SA has been approved by Network Rail's Sale of Access Rights Panel (SoAR). It notes the benefits and therefore supports the application.
