

Common Traffic Signs at public vehicular road level crossings

This document provides a list of common traffic signs at public vehicular road level crossings (including road markings). It is not a list of every traffic sign that could or should be used at a level crossing. Each level crossing requires a site-specific assessment to determine what traffic signs should be placed. For more information on traffic signs, including how they should be placed, the [Traffic Signs Regulations and General Directions 2016](#) and the [traffic sign manual](#) should be consulted.

'Diagram', followed by a number, is provided for each traffic sign. This is how they are referred to in the regulations and level crossing orders. A description that is provided for ease of reference follows. Any commonly used terms to refer to the sign are also provided.

Location refers to where in the Traffic Signs Regulations and General Directions 2016 the traffic sign is contained. This consists of a Schedule, the Part of the Schedule, and the Item number in the table for that Part.






Diagram 782: risk of grounding sign




Diagram 1004.1: warning line road marking




Diagram 1012.1: edge of carriageway line




Diagram 1014: deflection arrows




Diagram 1026: keep clear road marking




Diagram 1045: yellow box road marking




Diagram 1045.1: yellow box road marking for one-way roads




Diagram 3014: road traffic signal at a level crossing




Diagram 4006: pedestrian signal at a level crossing
