# Approval of the 25th supplemental agreement to the track access contract between Network Rail Infrastructure Limited and Abellio ScotRail Limited dated 3 March 2016

We have today approved the above supplemental agreement submitted to us formally on 14 March 2022 under section 22 of the Railways Act 1993 (the Act). This follows an earlier informal submission of a draft agreement for our consideration. This letter explains the reasons for our decision.

#### **Purpose**

The purpose of this agreement is to grant Abellio ScotRail (ASR) the rights necessary to operate its timetable for the Subsidiary Change Date 2022. The amendments effected by the 25th SA are extensive and primarily involve:

- An increase in services between Edinburgh and Dundee;
- An increase in services between Glasgow Queen street and Dundee;
- An increase in services between Edinburgh and Perth;
- All rights to Newcastle to either terminate or originate at Carlisle; and
- A reduction in services between Edinburgh and Falkirk Grahamston and in local Fife services.

These amendments will take effect on the Subsidiary Change Date 2022 and will expire on the Expiry date or earlier termination of ASR's track access contract.

## **Industry consultation**

Network Rail undertook the usual industry consultation. No comments or queries were received.

#### **ORR** review

Our review of the application raised no operational, economic or performance queries, nor any issues with the drafting of the agreement.

### Our duties under section 4 of the Act and our decision

We have concluded that approval of this supplemental agreement strikes the appropriate balance in discharging our statutory duties under section 4 of the Act; in particular, those relating to protecting the interests of users of railway services (section 4(1)(a)), promoting the use of the railway network for the carriage of passengers (section 4(1)(b)) and enabling persons providing railway services to plan their businesses with a reasonable degree of assurance (section 4(1)(g)).
