## This 51st SUPPLEMENTAL AGREEMENT is dated 1st July 2023 and made between:

- (1) <u>NETWORK RAIL INFRASTRUCTURE LIMITED</u>, a company registered in England under company number 02904587, having its registered office at Waterloo General Office, London, SE1 8SW ("Network Rail"); and
- (2) TRANSPENNINE TRAINS LIMITED, a company registered in England under number 12544930 having its registered office at Great Minister House, 2<sup>nd</sup> Floor Franchise Resilience and Mobilisation Team, 33 Horseferry Road, London, SW1P 4DR.

### **Background:**

- (A) Network Rail and First Transpennine Express Limited entered into a Track Access Contract (Passenger Services) dated 03 March 2016 as amended by various supplemental agreements (which Track Access Contract as subsequently amended is hereafter referred to as the 'Contract').
- (B) On 28<sup>th</sup> May 2023, the rights and obligations of First Transpennine Express Limited under the contract were transferred to the Train Operator pursuant to a transfer scheme made by the Secretary of State for Transport on 28<sup>th</sup> May under Schedule 2 of the Railways Act 2005.
- (C) The parties propose to amend the Contract in the manner and on the terms described below.

#### IT IS HEREBY AGREED as follows:

#### 1. INTERPRETATION

- 1.1 In this Supplemental Agreement words and expressions defined in and rules of interpretation set out in the Contract shall have the same meaning and effect when used in this Supplemental Agreement expect where the context requires otherwise.
- 1.2 "Effective Date" means: The date of signature of this Supplemental Agreement.

## 2. ORR GENERAL APPROVAL

This Supplemental Agreement is entered into pursuant to the Passenger Access (Short Term Timetable and Miscellaneous Changes) General Approval 2023.

#### 3. EFFECTIVE DATE AND TERM

The amendments to the Contract as set out in this Supplemental Agreement shall have effect from the Effective Date and shall cease to have effect on the Expiry Date or earlier termination of the Contract.

## 4. RETROSPECTIVE EFFECT

Notwithstanding the Effective, the amendments shall be applied retrospectively from 23<sup>rd</sup> July 2023.

#### 5. AMENDMENTS TO THE CONTRACT

The Contract shall be amended as follows:

Appendix 1 of Schedule 8 will be deleted and replaced in its entirety with the version set out in Annex 1 to this Supplemental Agreement.

#### 6. General

The Contract, as amended by this Supplemental Agreement, shall remain in full force and effect in accordance with its terms, and during the period in which amendments made by this Supplemental Agreement are to have effect all references in the Contract to "the contract", "herein", "hereof" and other similar expressions shall, unless the context requires otherwise, be read and construed as a reference to the Contract as amended by this Supplemental Agreement.

#### 7. THIRD PARTY RIGHTS

No person who is not a party to this Supplemental Agreement shall have any right under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of this Supplemental Agreement.

#### 8. LAW

This Supplemental Agreement shall be governed by, construed, and given effect to in all respects in accordance with the law of England and Wales.

## 9. COUNTERPARTS

This Supplemental Agreement may be executed in any number of counterparts, each of which when executed and delivered shall constitute an original, but all the counterparts shall together constitute one and the same instrument.

**IN WITNESS** of which Network Rail and the Train Operator have, by their duly authorised representatives, respectively entered into this Supplemental Agreement on the date first above written.
