THIS 47TH SUPPLEMENTAL AGREEMENT is dated 7th November 2024 and made

Between:

- (1) Network Rail Infrastructure Limited, ("Network Rail"), a company registered in England under number 2904587 having its registered office at Waterloo General Office, London, SE1 8SW; and
- (2) ScotRail Trains Limited, (the "Train Operator"), a company registered in Scotland under number SC328826 having its registered office at Atrium Court, 50 Waterloo Street, Glasgow, United Kingdom, G2 6HQ, United Kingdom.

Background:

- (A) The Train Operator and Network Rail entered into a Track Access Contract (Passenger Services)(which is hereafter referred to as the "Contract") dated 03 March 2016 in a form approved by the Office of Rail and Road pursuant to section 18(7) of the Act.
- (B) The parties now propose to enter into this Supplemental Agreement in order to amend the Contract as described herein.

IT IS HEREBY AGREED as follows:

1. INTERPRETATION

In this Supplemental Agreement:

- 1.1 Words and expressions defined in and rules of interpretation set out in the Contract shall have the same meaning and effect when used in this Supplemental Agreement except where the context requires otherwise;
- 1.2 "**Effective Date**" means the later of the Principle Change Date (PCD) 2024 and the date upon which the Office of Rail and Road issues its approval, pursuant to Section 22 of the Act, of the terms of this Supplemental Agreement; and
- 1.3 "Appendix" shall mean the appendices and their relevant parts and attached hereto.

2. EFFECTIVE DATE AND DURATION

The amendments made to the Contract pursuant to this Supplemental Agreement shall have effect from the Effective Date and shall cease to have effect on the Expiry Date or earlier termination of the Contract.

3. AMENDMENTS TO THE CONTRACT

- 3.1 In Schedule 5 of the Contract, the parts of table 2.1 relating to services 5870: Fife and Leven, 579: Glasgow / Dumfries – Carlisle, and 562: Glasgow Suburban Electrics South shall be deleted in their entirety alongside associated footnotes and replaced with the tables and associated footnotes in Appendix A to this 47th supplemental agreement.
- 3.2 In Schedule 5 of the Contract, the parts of table 2.2 relating to services 563: Argyle Line (Westbound), and 563: Argyle Line (Eastbound) shall be deleted in their entirety alongside associated footnotes and replaced them with the tables relating to services 563: Argyle Line (Westbound), and 563: Argyle Line (Eastbound) and associated footnotes in Appendix B to this 47th supplemental agreement.
- 3.3 In Schedule 5 of the Contract, the table relating to service 5870: Fife and Leven and associated footnotes as shown in Appendix B to this 47th supplemental agreement shall be added to table 2.2.
- 3.4 In Schedule 5 of the Contract, the part of table 4.1 relating to Service 563: Argyle Line (Eastbound) shall be deleted in its entirety and replaced with the table in Appendix C to this 47th supplemental agreement.

4. EFFECT OF THIS SUPPLEMENTAL AGREEMENT ON THE CONTRACT

The Contract, as amended by this Supplemental Agreement, shall remain in full force and effect in accordance with its terms, and during the period in which the amendments made by this Supplemental Agreement are to have effect all references in the Contract to “the contract”, “herein”, “hereof”, “hereunder” and other similar expressions shall, unless the context requires otherwise, be read and construed as a reference to the Contract as amended by this Supplemental Agreement.

5. LAW

This Supplemental Agreement shall be governed by, construed and given effect to in all respects in accordance with the laws of Scotland.

6. THIRD PARTY RIGHTS

No rights shall be conferred under or arising out of this Supplemental Agreement on any person other than the Parties to this Supplemental Agreement and there shall not be created in any circumstances a jus quaesitum tertio in favour of any person.

7. COUNTERPARTS

This Supplemental Agreement may be executed in any number of counterparts, each of which when executed and delivered shall constitute an original, but all the counterparts shall together constitute one and the same instrument.
