THIS SEVENTEENTH SUPPLEMENTAL AGREEMENT is dated 12 August 2025 and made

BETWEEN:

- (1) <u>NETWORK RAIL INFRASTRUCTURE LIMITED</u>, ("Network Rail"), a company registered in England under number 2904587, having its registered office at Waterloo General Office, London, SE1 8SW; and
- (2) <u>EAST COAST TRAINS LIMITED</u>, (the "<u>Train Operator</u>"), a private company limited by shares registered in England under company number 08765536, having its registered office at 8th Floor, The Point, 37 North Wharf Road, London W2 1AF.

WHEREAS:

- (A) The parties entered into a Track Access Contract (Passenger Services) dated 3 October 2016 following directions issued by the Office of Rail and Road pursuant to Section 17 of the Act (the "Agreement").
- (B) The parties wish to amend the Agreement in the terms described below.

IT IS HEREBY AGREED as follows:

1. <u>INTERPRETATION</u>

In this Supplemental Agreement, words and expressions defined in and rules of interpretation set out in the Agreement shall have the same meaning and effect when used in this Supplemental Agreement except where the context requires otherwise.

2. EFFECTIVE DATE AND TERM

- 2.1 The amendments made to the Agreement as set out in this Supplemental Agreement shall have effect from the Effective Date.
- 2.2 "Effective Date" means the later of:
 - a) the date on which the Office of Rail and Road issues its approval pursuant to Section 22A of the Act, of the terms of this Supplemental Agreement; and
 - b) 02:01 on 14 December 2025.

3. <u>AMENDMENTS TO THE AGREEMENT</u>

- 3.1 Table 2.1: Passenger Train Slots which follows paragraph 1 in Schedule 5 shall be deleted and replaced by the table as set out in Appendix 1 to this Supplemental Agreement.
- 3.2 Schedule 5: Paragraph 2.3 "Not Used" shall be deleted and replaced by "In order to provide through Services the Train Operator has Firm Rights to combine Passenger Train Slots at Edinburgh Waverley".
- 3.3 Table 4.1: Calling Patterns which follows paragraph 3 in Schedule 5 shall be deleted

and replaced by the table as set out in Appendix 2 to this Supplemental Agreement.

4. <u>EFFECT OF THIS SUPPLEMENTAL AGREEMENT ON THE AGREEMENT</u>

The parties agree that the Agreement, as amended by this Supplemental Agreement, shall remain in full force and effect in accordance with its terms, and during the period in which the amendments made by this Supplemental Agreement are to have effect, all references in the Agreement to "the Agreement", "herein", "hereof", "hereunder" and other similar expressions shall, unless the context requires otherwise, be read and construed as a reference to the Agreement as amended by this Supplemental Agreement.

5. THIRD PARTY RIGHTS

No person who is not a party to this Supplemental Agreement shall have any right under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of this Supplemental Agreement.

6. **LAW**

This Supplemental Agreement shall be governed by, construed and given effect to in all respects in accordance with English law.

7. **COUNTERPARTS**

This Supplemental Agreement may be executed in any number of counterparts, each of which when executed and delivered shall constitute an original, but all the counterparts shall together constitute but one and the same instrument.
