Thank you for the opportunity to comment on the GNWR Section 18 Application to run services between London and Blackpool from December 2017.

Further to our response of 7<sup>th</sup> July 2014, Northern Rail has the following comments to make on behalf of the new franchisee.

- Northern Rail notes this application replicates the rights sought in the application made by GNWR in June 2014 albeit a reduction in the previous application and understands that Network Rail has agreed to sell the London Blackpool rights in relation to the June 2014 application and that the rights sought in the application have been put to Network Rail's SoAR panel.
- Whilst Northern acknowledges that these proposals improve connectivity for Northern Towns and provides new direct links to London we would like to understand the impact on our existing capacity and performance, we also believe that these proposal are detrimental to the future franchises revenue stream and that they are primarily abstractive.
- Northern would like clarification regarding the stabling of the Rolling Stock as to whether there would be a requirement for any diagrams to start or finish at Blackpool and seeks assurance that this would not be to the detriment of our services to and from Liverpool and Manchester.

We welcome your response in relation to our comments raised.
