# Consultation on improvements to the drafting of Schedules 4, 7 and 8 of the passenger and freight model track access contracts

The purpose of this letter is to invite suggestions for improvements to the drafting of Schedules 4, 7 and 8 of the model freight and passenger track access contracts ('model contracts'). We would welcome comments from current or prospective franchised passenger operators, freight operators, open access operators and others.

Train operators wanting to access Network Rail's network need a track access contract with Network Rail, and such a contract must have ORR's approval. We have published model contracts that set out standard terms for such access, including each party's rights and obligations relating to charging and the rights to run services. We expect Network Rail and train operators to use these model contracts.

The existing charging and incentives regime is set out in Schedules 4, 7 and 8 of the model contracts. As part of our 2018 Periodic Review of Network Rail (PR18), we are reviewing the charging and incentives framework in place between Network Rail and train operators, and this provides an opportunity to improve the clarity, consistency and simplicity of the contractual drafting in these model contracts.

We have confirmed a number of policy changes we intend to make to charges and incentives as part of PR18, and we will conclude on the remaining policy areas in due course. Changes to our policy on charges and incentives and how this is implemented in the model contracts are outside the scope of this consultation.

## What we are seeking views on

We are seeking specific proposals for how the existing drafting of Schedules 4, 7 and 8 of the model contracts could be improved to address:

- 1. Any uncertainty and ambiguity in the drafting;
- 2. Any aspect of the contractual drafting which stakeholders consider does not reflect the established policy intent;
- 3. Inconsistent wording within the contracts;
- 4. Any aspect of the contractual drafting which does not reflect or allow for current or desired commercial practices; and

5. Any opportunities for simplification of the drafting, while retaining the established policy intent.

We also welcome suggestions from stakeholders for new wording to reflect other relevant developments, such as technological improvements in billing processes, or any possible improvements to processes associated with these Schedules.

In providing your response to this consultation, **please complete the table in Annex 1 with your suggestions**, ideally supported with marked-up contractual drafting for any significant proposed changes. However, if you would find it easier to respond in a different format then please feel free to do so. The model contracts are available on the ORR website here (<u>http://orr.gov.uk/rail/access-to-the-network/track-access/forms-modelcontracts-and-general-approvals</u>).

We are **not** seeking feedback on:

- The substance of our policies relating to charges and incentives, and any changes required to implement them; and
- Drafting of elements of the contract that will not apply (and will need to be removed in the model contracts) for control period 6, reflecting those policy decisions made in PR18. These relate to the capacity charge and the coal spillage charge.

We are aware that Network Rail is consulting on five possible changes to the model contracts<sup>1</sup>. We intend to take responses to this Network Rail consultation into consideration (subject to any requests for confidentiality by the respondents to it) when we decide what changes to make to the model contracts.

## Next steps, and how we will use your input

Using responses to this consultation (and to Network Rail's, where appropriate), we will identify how we can improve the drafting of Schedules 4, 7 and 8 of the model contracts and look to implement these improvements.

We intend to consult on our proposed updated model contracts in mid-2018, following our draft determination. The updated contracts will reflect both the drafting improvements identified through this consultation and our policy decisions on charges and incentives.
